#### **WASPLC JOURNAL ISSUE 2 PUBLISHED**

The June 2025 WASPLC Journal (Volume 1, Issue 2), published by the Washington Systematic Policy and Learning Center, presents research and policy proposals to promote principled governance across education, local governance, natural resource management, and judicial reform. It emphasizes transparent, legally grounded solutions to empower citizens and strengthen self-governance, addressing issues like water rights, constitutional freedoms, and equitable policy reform.

The papers focus on education, local, state, and federal reforms and challenges: Milana Pilkinton, Pamela Leslie, and Terri McCoy propose educational neutrality and OSPI election accountability. Tanya Goodman's paper calls for family court reforms to ensure due process. Steve McCoy defines extremism terms and promotes human dignity and Corey Gibson's resolution protects liberties from vague mandates. Dick Ewing critiques Okanogan County's zoning, and. Dick Ewing proposes quantifying subsurface water to counter scarcity assumptions, amending the 1854 Medicine Creek Treaty to clarify tribal fishing rights, and balancing wildlife conservation with rural economies via the Apex Predator and Agricultural Protection Act. Mark Herr's RARS Resolution rejects racial supremacy and violence, while his analysis of Everett's Initiative 24-03 critiques ecosystem personhood risks.

#### CENTER FOR SELF GOVERNANCE TRAINING FOR WAGOP

The Washington State GOP is offering training through Center for Self Governance for PCO's across the state. This training teaches the structure of government and the history of how partisan politics has evolved, enabling students to understand and navigate the system of government. This is the first time in the history of Washington State that such leadership training has been offered. The training opens up a myriad of opportunities previously unknown by PCOs.
